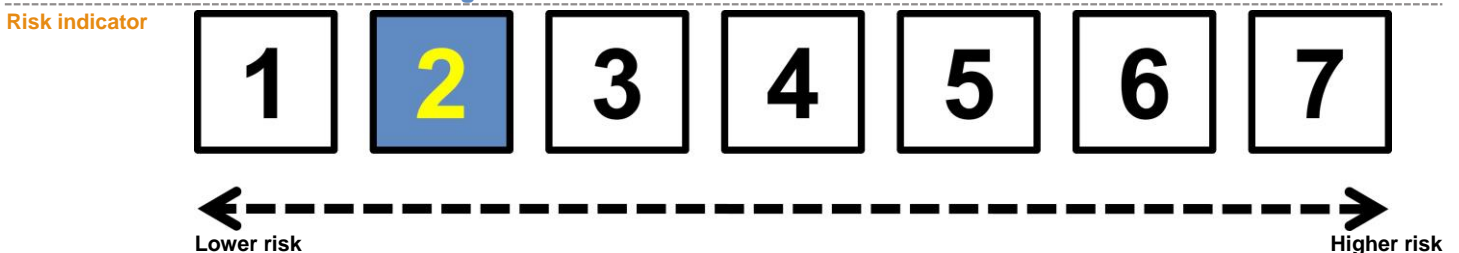

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type	The product is in the form of a note issued under English law. It is not interest bearing security. The payment obligations of the product manufacturer are not guaranteed by any entity.
Term	The product has a fixed term and will be due on May 17, 2029.
Objectives	The product pays interest that is linked to the performance of the underlying asset (as defined below). What you will receive at the end of the term of the product is not certain and will depend on the performance of the index EURO STOXX 50® Index (Price EUR) (the underlying asset). The product has a fixed term, ending on May 17, 2029. Each note has a face value of EUR 1,000. The issue price is 100.00% of the face value. The product will be listed on Luxembourg Stock Exchange (Main Segment). The issue date is May 17, 2024. Repayment at maturity: On May 17, 2029, for each note that you hold. <ol style="list-style-type: none"> If the closing price of the underlying asset on May 10, 2029 is at least equal to the initial reference price, you will receive EUR 1,242.50; or <u>Otherwise</u>, you will receive EUR 1,000.00. The initial reference price of the underlying asset is the closing price on May 10, 2024. The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

What are the risks and what could I get in return?





The risk indicator assumes you keep the product until May 17, 2029. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a low level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

You are entitled to receive back at least 100.00% of the face value of the product. Any amount over this, and any additional return, depends on future market performance and is uncertain. However, this protection against future market performance will not apply if you cash in before May 17, 2029. If we are not able to pay you what is owed, you could lose your entire investment.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's past performance over a period of up to 5 years. How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The recommended holding period for the product is 5 years as the product is designed to be held until maturity; however the product may terminate early due to an extraordinary event. You have no contractual right to terminate the product prior to maturity. The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.
