

Purpose

This document provides you with key information about this investment product. It is not marketing material. The information is required by law to help you understand the nature, risks, costs, potential gains and losses of this product and to help you compare it with other products.

You are about to purchase a product that is not simple and may be difficult to understand.

What is this product?

Type The product is in the form of a note issued under English law. It is not an interest bearing security. The payment obligations of the product manufacturer are guaranteed by Goldman Sachs International.

Term The product has a fixed term and will be due on July 17, 2029, subject to an early redemption.

Objectives The product provides the potential for capital growth and does not pay interest. What you will receive at the end of the term of the product is not certain and will depend on the performance of the index EURO STOXX 50® Index (Price EUR) (the **underlying asset**). In addition, you will take the risk that some or all of the value of your investment may be lost at the end of the term of the product. The term of the product will end no later than July 17, 2029. However, the product may terminate early depending on the performance of the underlying asset. Each note has a face value of EUR 1,000. The issue price is 100.00% of the face value. The product will be listed on Luxembourg Stock Exchange (Main Segment). The subscription period is from May 24, 2024 to July 10, 2024. The issue date is July 17, 2024.

Autocall feature: If the closing price of the underlying asset on any autocall observation date is at or above 100.00% of the initial reference price, the product will terminate on the corresponding autocall payment date. In this case, you will receive the autocall payment shown below for each note that you hold.

† This is an indicative value. The actual value could be, subject to. The actual value will be determined by us on July 10, 2024, taking into account the market conditions on such date. This document will be updated with the actual value at that time.

Repayment at maturity:

This section applies only if no autocall occurs as described above.

On July 17, 2029, for each note that you hold:

- If the closing price of the underlying asset on July 10, 2029 is at least equal to the initial reference price, you will receive EUR 1,240.00; or
- If the closing price of the underlying asset on July 10, 2029 is at least equal to the barrier price, you will receive EUR 1,000.00; or
- Otherwise, you will receive EUR 1,000.00 multiplied by (i) the closing price of the underlying asset on July 10, 2029 divided by (ii) the strike price of the underlying asset.

The initial reference price of the underlying asset is the closing price on July 10, 2024.

The strike price is 100.00% of the initial reference price. The barrier price is 70.00% of the initial reference price. The autocall barrier is 100.00% of the initial reference price.

The product terms also provide that if certain exceptional events occur (1) adjustments may be made to the product and/or (2) the product issuer may terminate the product early. These events are specified in the product terms and principally relate to the underlying asset, the product and the product manufacturer. The return (if any) you receive on such early termination is likely to be different from the scenarios described above and may be less than the amount you invested.

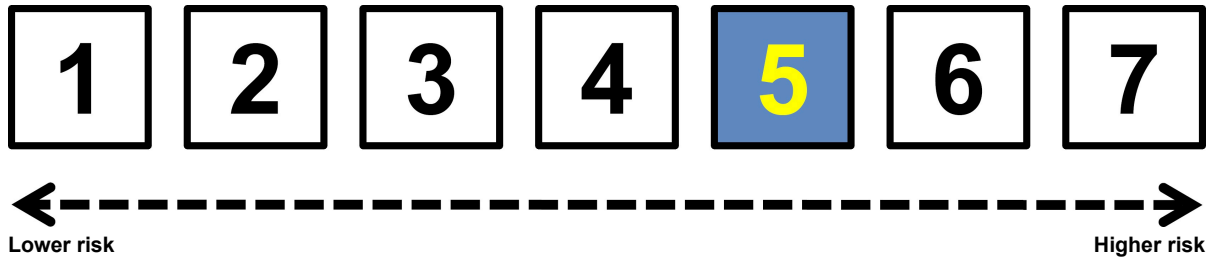
Intended retail investor The product is intended to be offered to retail investors who:

- have the ability to make an informed investment decision through sufficient knowledge and understanding of the product and its specific risks and rewards, with experience of investing in and/or holding a number of similar products providing a similar market exposure;
- seek capital growth, expect the movement in the underlying asset to perform in a way that generates a favourable return, have an investment horizon of the recommended holding period specified below and understand that the product may terminate early;

3. accept the risk that the issuer or guarantor could fail to pay or perform its obligations under the product but otherwise are able to bear a total loss of their investment;

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product until July 17, 2029. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This takes into account two elements: (1) the market risk - that the potential losses for future performance are rated at a medium-high level; and (2) the credit risk - that poor market conditions are deemed very unlikely to impact our capacity to pay you.

This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.

Inflation erodes the purchasing value of cash over time and this may result in the decline in real terms of any capital reimbursed.

Performance scenarios What you will get from this product depends on future market performance. Market developments in the future are uncertain and cannot be accurately predicted.

The favourable, moderate, unfavourable and stress scenarios represent possible outcomes that have been calculated based on simulations using the reference asset's past performance over a period of up to 5 years. In the case of an early redemption, it has been assumed that no reinvestment has occurred. The stress scenario shows what you might get back in extreme market circumstances. This product cannot be easily cashed in. If you exit the investment earlier than the recommended holding period you may have to pay extra costs.

What happens if Goldman, Sachs & Co. Wertpapier GmbH is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest and how long you hold the product. The amounts shown here are illustrations based on an example investment amount and different investment periods.

The duration of this product is uncertain as it may terminate at different times depending on how the market evolves. The amounts shown here consider two different scenarios (early call and maturity). In case you decide to exit before the product ends, exit costs may apply in addition to the amounts shown here.

*This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at maturity your average return per year is projected to be 5.7% before costs and 4.4% after costs.

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

The recommended holding period for the product is 5 years as the product is designed to be held until maturity; however the product may terminate early due to an autocal or an extraordinary event. You have no contractual right to terminate the product prior to maturity.

The manufacturer is under no obligation to make a secondary market in the product, but may repurchase the product prior to maturity on a case-by-case basis. In such circumstances, the price quoted will reflect a bid-ask spread and any costs associated with unwinding the hedging arrangements of the manufacturer in connection with the product. In addition, the person who sold you the product may charge you brokerage fees when you sell the product.

How can I complain?
