The product has a fixed term and will be due on 16 May 2029.

The product is designed to provide a return in the form of (1) conditional interest payments and (2) a cash payment on the **maturity date**. The risk indicator assumes you keep the product until 16 May 2029. The actual risk can vary significantly if you cash in at an early stage and you may get back less. You may not be able to sell your product easily or may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 5 out of 7, which is a medium-high risk class. This rates the potential losses from future performance of the **underlying** at a medium-high level and the potential for us to be unable to pay you any amounts due as very unlikely.
